Dear Chairman Grassley and Ranking Member Durbin:

On behalf of the Coalition Against Socialized Medicine (CASM), we urge you to support the Promoting and Respecting Economically Vital American Innovation Leadership (PREVAIL) Act. As a coalition of free-market organizations, we champion legislation that fosters innovation and strengthens competition in our pharmaceutical sector. The PREVAIL Act advances these principles by modernizing and reforming our patent system to eliminate barriers that currently disincentivize medical development.
